## COVID-19 Stage 2 Court Hire Terms and Conditions

Yeronga Tennis Club Incorporated (the Club) uses the Skedda online booking system (the System) to hire its courts. The Club is revising its court hire terms and conditions from Saturday 13 Jun 2020 to reflect Stage 2 easing of Queensland's COVID-19 restrictions.

The booking conditions in the System have changed in respect of the following

**Cancellations** – Allowed up to the commencement time of the booking. The Hirer can request a cancellation for wet weather or exceptional circumstances by emailing [bookings@yerongatennisclub.com.au](mailto:bookings@yerongatennisclub.com.au) after the commencement time of the booking but before midnight on the Sunday following the booking.

**Booking window** – 90 days

**Permanent Bookings** – Reinstated from Saturday 13 June 2020

**Booking Duration** – Maximum of 4 hours

**Prices** – Increased by \$1 per hour above pre COVID-19 rates except for Members

Any Hirer who uses the System to hire the Clubs courts accepts the above system changes and the following special COVID-19 Stage 2 Terms and Conditions specific to our venue.

**By making a booking or on the reinstatement of my permanent booking, the Hirer (I or You) confirms**

**1 - That I am aware that the maximum number of persons allowed on the premises is 4 per court booked and I will enter the names of my guests in the ' Guest's Names' section of my booking form.**

**2 - That I am aware of and will comply with the revised COVID-19 Stage 2 booking conditions as set out below and displayed prominently throughout the venue**

### COVID-19 STAGE 2 CONDITIONS FOR ENTRY TO THE PREMISES

#### YOU MUST NOT ENTER THESE PREMISES

- IF YOU DON'T HAVE A BOOKING OR ARE NOT A GUEST OF A BOOKING HOLDER.
- IF YOU HAVE BEEN IN CONTACT WITH SOMEONE WITH COVID-19 IN THE LAST 14 DAYS
- IF YOU HAVE BEEN OVERSEAS IN THE LAST 14 DAYS
- IF YOU HAVE FLU-LIKE SYMPTOMS

YOU ARE ADVISED NOT TO ENTER THESE PREMISES IF YOU ARE IN A HIGH RISK HEALTH CATEGORY. THE GOVERNMENT'S DEFINITION OF PEOPLE IN A HIGH RISK HEALTH CATEGORY IS COPIED BELOW.

- ABORIGINAL AND TORRES STRAIGHT ISLANDER PEOPLE AND PEOPLE LIVING IN REMOTE COMMUNITIES
- OLDER PEOPLE
- PEOPLE IN AGED CARE FACILITIES
- PEOPLE WITH CHRONIC CONDITIONS
- PEOPLE WITH DISABILITY

**IF YOU ARE IN A HIGH RISK HEALTH CATEGORY, YOU ENTER THE PREMISES AT YOUR OWN RISK.**

#### **COVID-19 STAGE 2 CONDITIONS WHILST ON THE PREMISES**

##### **GENERAL REQUIREMENTS**

- **IF YOU TOUCH IT -> WIPE IT. AVOID TOUCHING ANYTHING BUT IF YOU DO, WIPE IT WITH A SANITISER FROM THE SANITISING STATION AND DISPOSE OF USED WIPES IN THE BIN PROVIDED.**

##### **SPECIFIC REQUIREMENTS**

- **SANITISE YOUR HANDS BEFORE AND AFTER PLAY**
- **AVOID TOUCHING YOUR FACE**
- **COUGH OR SNEEZE INTO YOUR ELBOW RATHER THAN INTO THE AIR OR YOUR HANDS. SANITISE YOUR HANDS AFTER COUGHING IN YOUR HANDS.**
- **DO NOT ENTER OR TOUCH ANYTHING IN A MARKED OFF AREA..**
- **KEEP 1.5 METRES AWAY FROM OTHER PEOPLE. NO PRE OR POST GAME HAND SHAKES.**
- **BRING YOUR OWN WATER AND DO NOT SHARE WATER BOTTLES.**
- **KEEP YOUR DISTANCE FROM PEOPLE WHO ARE OBVIOUSLY SICK**

#### **COVID-19 STAGE 2 CONDITIONS FOR LEAVING THE PREMISES**

##### **GENERAL REQUIREMENTS**

- **PLEASE LEAVE THE PREMISES AS A GROUP NO MORE THAN 10 MINUTES AFTER YOUR BOOKING ENDING TIME.**

##### **SPECIFIC REQUIREMENTS**

- **THE BOOKING HOLDER IS RESPONSIBLE FOR SWITCHING OFF LIGHTS AND SECURING THE PREMISES (Clubhouse, Roller Door and Front Gate) BUT ONLY IF THERE ARE NO OTHER PERSONS ON THE PREMISES.**
- **GUESTS SHOULD ONLY PERFORM THESE TASKS IF THERE ARE NO OTHER PERSONS ON THE PREMISES. SANITISE YOUR HANDS BEFORE AND AFTER EACH LOCKING PROCEDURE.**

**3 - That I take responsibility for ensuring that my guests are aware of and comply with the COVID-19 Stage 2 Conditions. This includes the obligation to direct any guest to immediately leave the premises if they show flu like symptoms or do not meet any of the other conditions for entry to the premises.**

**4 - That before entering the premises, I have watched the Club's COVID-19 Stage 2 Induction Video and understand my responsibilities especially in relation to the correct procedures for opening and closing the Clubhouse, Roller Door and Front Gate.**

#### **Payment for Bookings**

Any booking remaining in the System at midnight on each Sunday for the previous week will be deemed to have been used by the Hirer and the Hirer is liable to pay for it at the price shown on the booking.

All bookings will be required to be paid by card through the System. Cards will be charged on a weekly basis for all bookings in the System for the previous week ending midnight Sunday. The Hirer will be advised promptly by email of all charges made to their card.

### **General Conditions**

The Hirer agrees to:

- Only use the courts and lighting (if applicable) for the duration of the booking.
- Compensate the Club for the cost of repairs or replacement of any damage caused by the Hirer and the Hirer's guests to the courts and the clubhouse.
- Refrain from doing or permitting anything to be done at the courts or clubhouse or any part of it, which may be or become a nuisance or annoyance to the owners, tenants or occupiers of other properties in the neighbourhood,
- Notify the Club by email to [bookings@yerongatennisclub.com.au](mailto:bookings@yerongatennisclub.com.au) of any occurrence that may have damaged the courts and clubhouse or caused injury or damage to a person.

### **Indemnity**

To the maximum extent permitted by Law, the Hirer agrees to Indemnify the Club its servants, employees and agents and hold them harmless from and against all damages, costs, actions, claims and demands arising from any injury to, **and from any breach of these conditions by**, the Hirer and the Hirer's guests.
